1. S podpisom razumem in vztrajam, da pogodbene vezi med mano (članom - poslovnim partnerjem) in podjetjem (4EVERLIFENET) niso in ne morejo biti ne zaposlitvene narave, niti v odvisnem razmerju pri opravljanju dela ali storitev podjetja (v skladu z 18.členom Zdoh).
 2. V primeru da bom postal samostojni podjetnik, oziroma, če bom spremenil svoj davčni in/ali civilni status, bom sam odgovoren za plačilo davkov, dovoljenj in drugih zakonskih prispevkov in dajatev, ki jih je ali jih bo potreben plačati
 3. Razumem , da je dejavnost člena določena in opisana v pravilniku za člane in poslovne partnerje (poslovna administracija). Dejavnost je opisana tudi na info srečanjih članov.
 4. S podpisom te pogodbe izrecno dovoljujem obdelavo, hrambo, prenos in posredovanje vseh svojih osebnih podatkov za potrebe podjetja, oziroma potreb njegovih matičnih in/ ali hčerinskih družb, in sicer neomejeno za potrebo priprave in oddajo davčnih obrazcev, računovodskega listin ipd..

ENGLISH LANGUAGE

I, the undersigned, declare, with which 4EVERLIFENET agrees, that;

1. By signing I understand and insist that contracting bonds between me (member/business partner) and the company (4EVERLIFENET) are not and can not be of an employment nature, nor in a depending relationship at performing business or company's services (accordance with Article 18. of the Personal Income Tax Act (Zdoh)).
 2. In case I become an independent entrepreneur or if I change my tax and/or civilian status I will solely be responsible for paying taxes, licenses and other legal contributions and tributes that has to be paid or will have to be paid.
 3. I understand that member activity is defined and described in the rule book for members (business administration). Activity is also presented in members' info meeting.
 4. By signing this contract I explicitly allow handling, storage, transfer and mediation of all my personal information for the need of the company or for the needs of its parent and/or subsidiary companies, that is, limitlessly for the need of preparation and submission of taxation forms, accounting documents, etc...
 5. By signing this contract, I state that; I am an adult and that I am fully acquainted with company's general rules and instructions.
 6. As a member I understand that I have the right, but not also the obligation, to collect and mediate orders from a third party for purposes of advertising discount spots, 4ELN product purchases, 4EVERLIFENET tourist arrangements or their business partners at home or abroad.
 7. That orders are formulated on summaries, which are filled in by the member in two copies. One copy of the order or contract is given to the member the other is mediated to the company, along with proof of payment for an ordered service, product or tourist arrangement, except in the case when the client paid the quote or by credit card.
 8. In every current month, a member has the right to order up to 500 BT of personal order (for personal use) at a price of personal order. A member undertakes that products bought as personal order will not be resold.
 9. 4EVERLIFENET can deliver products or propaganda material to members or customers under the conditions set for the delivery of products and propaganda material on the territory of the Republic of Slovenia.
 - up to 168,00 €(EU) , 300,00 € others countries — postage is paid according to the official postal rates of the Slovenian Post Office
 - over 168,00 €(EU) , 300,00 € others countries — free postage
 10. Member can participate in info meetings, seminars that are organized by the company, but otherwise adapts to organizers of weekly, monthly and yearly educations.
 11. A member has to receive company's written approval, for any agreement, which is not in accordance with the rules and principles of the company (use of sign or logo, publicity, advertisement, etc....)
 12. Prizes and awards for performed work are defined by the company in a written form and delivered to members in the first week of the current month at company's info meeting.
 13. A member can revoke the whole order within 8 (eight) days after receiving the products. In this case a member/business partner must inform the company in writing (registered mail) and return undamaged and unopened products within 16 (sixteen) day after the written notice was posted in the same quantity as ordered. After examination of returned products, that member gets a refund of already paid amounts. The company does not acknowledge open products and partial refunds, except when the quality of products is questionable and when they do not meet warranty terms. All revokes or orders of tourist arrangements are appointed with rules and regulations for tourist arrangements, which are stated on the back of the contract for holidaymaking and are a component part of this contract.
 14. Collaboration between a member/business partner and the company can stop;
 - whenever, with a written statement, signed by the member
 - if a member violates the rules prescribed by the company
 - automatically, if the member works for a competitive company
 - automatically, if the member invites or leads other members to work for a competitive company
 - automatically at the end of the 13th month after signing the contract, if the member does not renew the membership subscription. Membership lasts 12 (twelve) months.
 15. I bind myself that I will work as a good manager and will not harm the company with untruthful statements.
 16. I bind myself that in the case of ceasing my collaboration with 4EVERLIFENET Company, I will not work or collaborate with competitive company that markets tachyonized products or directly or indirectly deals with tachyon energy for one whole current year.
 17. I bind myself that in the case of ceasing my collaboration with 4EVERLIFENET Company I will not lead or use people in my group or 4EVERLIFENET's group to sell products of competitive company or to build networks irregardless to the activity of the other company.
 18. Any disagreement between a member and the company that can not be solved by mutual compact falls under the jurisdiction of the court in Ljubljana.
